1. Brief facts of the case.

1.1 Shri Naresh Kumar filed a complaint in PGC regarding harassment by BSES RPL since 26.3.2012 by raising inflated bill to the tune of Rs.1,44,000/-, disconnection of electricity and misbehavior with his family members.

2. Facts emerged during the proceedings

2.1 An ATR has been filed by the Manager, BSES RPL stating that the respondent department has already filed a criminal complaint bearing No.102 of 2013 against the complainant titled “BSES RPL Vs. Naresh Kumar” before the Special Electricity Court, District Court Dwarka, New Delhi. The said criminal complaint is presently pending before the court of Shri Mukesh Kumar, Jd. Addl.Sessions Judge, Special Electricity Court, District Court Dwarka, New Delhi and now listed for appearance of the accused on 23.05.2019.

That the Hon’ble Court vide order dated 09.10.2018 issued Non-Bailable Warrants against the complainant (herein) as he refused to receive the summons

issued by the Hon'ble Court. On the last date of hearing i.e. 12.2.2019, the criminal complaint was simply adjourned as the Hon'ble Court was on leave. It is evident that the complainant (herein) is not submitting to the jurisdiction of the Hon'ble Court and evading the service of summons issued by the Hon'ble Court. As a result of which the Hon'ble Court was constrained to issue NBW against the complainant (herein).

In view of the above as the matter is subjudice before the court of law, the Vigilance Department of the respondent has not proceeded with detailed examination of the matter. However, the Vigilance Department of the respondent called the complainant (herein), but he was reluctant to participate and stated that he does not have any record to prove his case as the matter is seven years old.

3. Directions

3.1 In view of the above, as the matter is subjudice before the Special Electricity Court, District Courts Dwarka, New Delhi, the case of the complainant is closed in the Commission as per mandate of the PGC.
