1. Brief facts of the complaint

1. Shri Rakesh Sharma filed a complaint in PGC on 5.10.2018 stating that he retired as Yoga Teacher on 31.1.2018 from Sri Sanatan Dharm Co-Ed.Sec.School but he has not received his pension & other terminals benefits even after a lapse of nine months. He has requested for early release of the same.

1.1 The Commission held several hearings in the case starting from 25.10.2018.

2. <u>Facts emerged during the proceedings.</u>

- 2.1 An ATR has been filed by Shri Anurag Yadav, Dy.Director of Education, Zone-20, GNCTD, stating that the pension case of Mr. Rakesh Sharma, Ex-Yoga Teacher has been completed. Gratuity, Pension Book, GPF and Commutation has already been handed over to him.
- 2.2 The complainant, who is present during the proceedings, has confirmed that the same have been received by him. However, he stated that the Leave Encashment still remains to be paid by the respondent department.

2.3 Dy.Director of Education, Zone-20 assured that the same will be released to the

complainant shortly as the same has already been processed by the Accounts Branch.

2.4 The complainant expressed satisfaction over action taken by the respondent and

also thanked the Commission in getting his long pending dues.

3. <u>Directions:</u>

3.1 The Commission appreciates the personal efforts made by Shri Anurag

Yadav, Dy.Director of Education, Zone-20, GNCTD, in releasing Gratuity, Pension

Book, GPF and Commutation to the complainant. Hence, the case of the

complainant is disposed of in the Commission with the advise to Dy.Director of

Education, Zone-20, GNCTD, to release the amount of leave encashment to the

complainant expeditiously and send a report to the Commission.

3.2 The complainant is also advised to intimate the Commission as soon as

amount of Leave Encashment is received by him.
