1. Brief facts of the complaint

1. Shri Gajraj Singh Dabas filed a complaint in PGC on 30.10.2018 regarding non-payment of retirement dues on account of encashment of Earned Leaves, MACP, Leave Travel Concession and delay in issuance of DGEHS Medical Card. He requested the PGC to do the needful.

2. <u>Facts emerged during the proceedings.</u>

- 2.1 An ATR has been received on 01.7.2019 from Dy.Director of Education, Distt. North West –B, GNCT of Delhi stating that "Average" remarks quoted by the then Reviewing Officer in the ACR for the period 2005-2006 in respect of Shri Gaj Raj Singh Dabas, PGT(Retd.) has been expunged and the remarks of the then Reporting Officer i.e. "Good" may prevail vide office letter dated 29.3.2019. As regards settlement of LTC in r/o Shri Gaj Raj Singh, it was informed that their District is not competent to take any action as the complainant has retired from the School which falls under the jurisdiction of DDE, South West(B).
- 2.2 Another ATR with regard to claim of the complainant for LTC amount for visiting Lashadweep has been filed on behalf of Dy.Director of Education, Distt. South West-B, GNCT of Delhi by the Vice Principal of Govt.Co-ed.S.S. School, Pochanpur, present today and the same is taken on record. He stated that the O/o. Distt. South West-B had written to Lakshdeep Tourism to provide the fare chart for the year 2014 but the same has not been

provided by them. HOS also requested the complainant to provide the Govt. fare chart for the year 2014 to support his claim but he also failed to do so.

Further, complainant is demanding the tour package paid to SPORTS(Society for promotion of Nature Tourism and Sports) for LTC for the year 2014. However, OM No.3101/10/2017-Estt-A-IV dated 11.10.2018 by Govt.of India clarified for tour package offered by SPORTS that only transportation charges shall be reimbursible. Further, Office Memorandum dated October 11, 2018, says that claims already settled before issue of this OM will not be re-opened.

2.3 Copy of the ATR along with annexures given to the complainant.

3. <u>Directions:</u>

3.1 In view of the submissions made by the representative of the respondent department present today and the material on record, the respondent department has taken needful action with regard to average remarks in the ACR for the period 2005-2006 in respect of the complainant and the same has been expunged and, secondly the grievance of the complainant with regard to his claim in respect of LTC amount for visiting Ladshdweep has been re-examined and found that the complainant has been reimbursed the LTC amount correctly and as per rules, the case of the complainant stands disposed of in this Commission.
