1. Brief facts of the complaint

Ms Sheekha Ahluwalia has filed a grievance in PGC regarding installation of 3 mobile towers on the terrace of Prashant Handa R/o C5A/258, Janakpuri, a densely populated area, which is a threat to human life, birds and animals.

2. Proceedings in the Public Grievances Commission

The PGC has convened first hearing in the matter on 21st Aug., 2019 and the following are present:

3. Relevant facts emerging during the hearing :

3.1 Sh. Athar Mustafa, Asstt. Engineer (B), West Zone is present in the hearing and submitted a Status Report stating that

“as per record of the office, M/s Indus Towers Limited had applied for regularization with respect to installation of Pole site at Property No. / House No. 258, Block-C-5A, Janak Puri, New Delhi – 110058 vide file ID No. 1335583 and the pole site has been regularized after depositing necessary charges of Rs. 20,000/- vide G-8 receipt No. 23530 dated 09.05.2018, as per terms &

conditions of new settlement arrived between Cellular Operators Association of India & MCD through mediation centre vide LPA No. 572/2011 on the terms & conditions as mentioned in the Settlement Policy.”

3.2 Complainant is not present in the hearing of the Commission.

4. Recommendations of the PGC

As per the report submitted by the concerned Asstt. Engineer (B) the mobile towers installed on the terrace of Property No.C-5A/25B, Janak Puri, New Delhi are regularized by the MCD and are installed as per the terms & conditions of the Settlement Policy of the MCD, the matter stands closed at the level of the PGC.
