1. Brief facts of the complaint

1.1 Shri Bhaskar Joshi has filed a grievance petition before Public Grievance Commission, aggrieved by non-payment of dues by M/s AVB Public School.

2. Facts emerged during the proceedings

- 2.1 Shri Shashi Bushan, Labour officer is present on behalf of Dy.Labour Commissioner(Admn.)/HOO of the respondent department and filed a report which has been taken on record. It is stated that "Sh. Bhaskar Josh has filed a complaint against the management of M/s AVB Public School alleging therein that management had not paid his due earned wages and terminated his services. Complaint of Sh. Bhaskar Joshi was also received from various other forums and higher authorities. Taking cognizance of all his complaint a notice dt. 4.10.2019 was served to the management with direction to appear on16.10.2019. On 16.10.2019 complainant appeared but management representative did not appear nor file any reply. Accordingly reminder notice was issued to the management with the direction to appear on 31.10.2019.
- On 1.11.2019 complainant and management representative Sh.Shyam Rawat appeared and request for short adjournment for payment of all legal dues to the complainant workman and matter was fixed for 8.11.2019. On 8.11.2019 management representative appeared along with the complainant workman Sh. Bhaskar Joshi, Management agreed to pay Rs. 10,500/- as a full and final payment

including due wages. The above said amount was received by the complainant Sh. Bhaskar Joshi.

The representative of the department has filed a photocopy of vouchers which shows the signature and receipt of Rs. 10,500/- by the complainant.

3. <u>Directions</u>

3.1 The grievance of the complainant has been resolved. The Commission has decided to close the case.
