1. Brief facts of the case

1.1 Sh. Raj Kumar has filed a grievance petition before Public Grievances Commission, aggrieved by raising inflated water bill in respect of meter K.No.3295340000 (Old WCN: 1628) at 29/15, East Baburpur, Shahdara, Delhi by Delhi Jal Board. The complainant has requested for Commission's intervention for direction to Delhi Jal Board for taking needful action in the matter.

2. Facts emerged during the proceedings.

- 2.1 Shri S.S. Mukhija,ZRO(NE)-III of the respondent department filed a report stating that "Water bill against K.No.3295340000 in the name of Sh.Raj Kumar R/o. 29/15, East Baburpur, Shahdara,Delhi-32, has been rectified."
- 2.2 The complainant is not present. It appears that he is not interested in prosecuting his case and is filing frivolous complaints in the Commission.

3. <u>Directions</u>:

Mukhija, ZRO(NE)-III, Delhi Jal Board, that due action has been taken on the grievance and the same has been resolved, the case of the complainant stands disposed of in the Commission. The complainant is advised to approach ZRO(NE)-III, DJB, first for redressal of his grievance before approaching the Commission.
