1. Brief facts of the complaint

Sh. Hot Chand Sabhnani has filed a complaint in PGC on 06.04.2017 regarding illegal and unauthorized construction work at property No. 13/10, East Patel Nagar, Delhi.

4. Recommendations of the PGC

4.1 There is long adjournment of the case by the ATMCD. We are, therefore, closing the matter with the directions that the

orders of the Tribunal should be complied with by the MCD. A copy of the order of ATMCD dated 13.12.2019 be submitted to the Commission.

4.2 The Complainant is advised to pursue the matter in the ATMCD and approach PGC on receipt of orders of ATMCD. If the orders of the ATMCD are not complied with by the MCD, then the matter will be reopened.

With the above directions in the matter the case stands closed at the level of this Commission.
