1. Brief facts of the case:

1.1 Dr. D.P.S. Verma has filed a grievance petition before PGC on 5.2.2019, aggrieved by inaction on part of Dte.of Training & Technical Education, GNCTD, for not releasing his 1st MACP for past nine years.

2. Facts emerged during the proceedings.

2.1 An Action Taken Report has been filed on behalf of Administrative Officer (E-II) of the respondent department which has been taken on record. It states that "It is telephonically confirmed from the complainant, Dr.DPS Verma that arrear/payment has been received by him.

Vide office order dated 22.11.2019, pay of Dr.D.P.S. Verma was fixed as per his option under provision FF22(1)(a)(1). His pay as on 07.08.2010 was fixed to Rs.21100 + 5400 GP after grant of 1st MACP on 08.08.2010, the pay fixed to Rs.21,900 + 6600 GP, the pay on 01.01.2016 (in level 11) was fixed to Rs.85,800/- and last pay drawn as on 31.07.2017 in level-11 was Rs.88,400/-. The matter has again been checked from the Accounts Branch and found no change. All eligible dues to Dr.DPS Verma have been paid.

2.2 The complainant is not present.

3. <u>Directions</u>

3.1 In view of the above fact that the respondent department has paid all eligible dues to the complainant with regard to his 1st MACP, as

mentioned in his complaint, the case is disposed in the Commission. However, if there is any discrepancy or other grievance, the complainant may file a representation with the respondent department for getting it resolved.
