1. **Brief facts of the case**

1.1 Smt. Munni Tayal has filed a grievance petition before Public Grievances Commission, aggrieved by non-refund of Rs.9,450/- extra charged against K.No.0370580000 installed at A-1/225, Keshav Puram, Delhi-35 by Delhi Jal Board. The complainant has requested for Commission's intervention for direction to Delhi Jal Board for taking needful action in the matter.

2. <u>Facts emerged during the proceedings.</u>

- 2.1 Sh.Naveen Harbola, Sr.Asstt on behalf of ZRO (NW)-III of Delhi Jal Board filed a report stating that the file has been approved by higher authority for the sum of Rs.9,150/- and which has been forwarded to the Accounts Section for making the payment to the applicant. The representative of ZRO(NW)-III further stated that he will inform the Commission through e-mail after making payment to the complainant.
- 2.2 The complainant is not present. However, it has been telephonically stated by the representative of the complainant that he cannot attend the hearing due to illness.

3. Directions:

- 3.1 The Chief Executive Officer to direct ZRO(W), NW-III, Ashok Vihar, to refund the excess amount in respect of the above said meter to the complainant within **two (02) days positively**. Further, the Commission be informed as and when payment is made and received by the complainant, as assured by the representative of the respondent department.
- 3.2 Sh. Bharat Bhushan Gaur, ZRO, NW-III, Ashok Vihar, to ensure that payment of refund of excess amount be released to the complainant within two days time positively.
- 3.3 The complainant is advised to inform the Commission in writing as soon as she receives the refund of amount extra charged by the respondent department.
- 3.4 With the above directions, the case of the complainant is disposed in the Commission.
