1. Brief facts of the complaint

Shri Kalimuddin has filed a grievance in this Commission against pvt. builders and Principal of the School, Sarvodaya Kanya Vidyalaya No.2, Zeenat Mahal, Lal Kuan, New Delhi who are encroaching, grabbing and doing illegal construction on the above said property of school.

2. Proceedings in the Public Grievances Commission

This Commission has convened fourteen hearings in the matter so far and in the hearing held on 05.02.2020, neither anyone is present from the Education Department nor any status report has been submitted inspite of the fact that the last orders of the Commission were marked to the Director of Education in his name cover and the same were forwarded to the DDE, Distt. Central and ADE(L&E) by DDE(HQ) on 13.01.2020. This has been viewed adversely by the Commission.

3. Relevant Facts that emerged during the hearing :

This matter has been dragging on in the commission for the last 1 and ½ years due to lack of initiative from the officers of the Education Department. This Commission gets the impression that

the Directorate of Education is totally indifferent in claiming the Govt. land in question which was purchased by them in the year 1964.

As the matter is regarding precious govt. land, senior officers of Directorate of Education, the land owning agency, need to take up the same with the concerned departments to know the extent of encroachment and take measures to remove the same. It is disappointing to note that the Education Department is not showing any interest in the matter and are treating the case as a routine one.

4. Recommendations of the Commission :

Sh. Binay Bhushan, Director, Directorate of Education is advised to take note of para 2 & 3 above, look into the matter personally and direct the concerned officers to take necessary action in the matter with the urgency it deserves so that the precious government land can be protected by the department.

With the above directions, the case stands closed at the level of this Commission.
