1 Brief facts of the case.

- 1.1 Shri Amar Nath Aggarwal has filed a grievance in PGC with regard to excess amount Rs. 990/- raised vide invoice no. 130010445755 dt. 23.11.2019, by Power department .
- 1.2 The complainant is present.

2. <u>Facts emerged during the proceedings</u>

2.1 Shri Rajan Kumar, Asstt. Manager, representing TPDDL is present and has filed an Action Taken Report and the same is taken on record. It is stated in the report that "the bill was well examined and it is found that raising the bill amount Rs. 990/-and levying of fixed charges in the bills raised during July 2018 to October 2019 are as per Power Purchase Adjustment Cost rate revision effected recently as per DERC's Regulations and relevant tariff order and the existing DERC's tariff schedule.

The details of both the issues raised in the complaint are presented as below:-

- i) Adjustment charges of Rs. 994.19 were posted in the bill no. 13001045755 dt. 23.11.2019 on account of PPAC rate revision.
- ii) Under load violation drive, load was enhanced from 2 KW to 3 KW on 1.7.2018 on the basis of MDI 0.8120 KW dt. 26.8.2017, 4.1.160 KW dt. 26.9.2017,

4.160 KW dt. 28.10.2017 and 4.160 KW dt. 29.11.2017. Hence FC (Fixed charges) are charged according to the load 3 KW."

- 2.2 The Commission observes that this amount is raised/demanded as per DERC's Regulations and tariff schedule.
- 2.3 Since this raise amount is charged as per rules and the same is well explained to the complainant so he showed his satisfaction.

3. <u>Directions</u>

3.1 The HOG (PA&LS) TPDDL has resolved the grievances of the complainant and now the complainant has no grievance with the TPDDL deptt., hence the matter is disposed of in the Commission.
