### **1. Background**

Shri Sanjay Aggarwal, appellant, vide his DRTI application dated 06/09/2019 has sought information from the Competent Authority viz. Deputy Commissioner (Shahdara South Zone), East DMC, on total 10 points.

Aggrieved with non-receipt of any information from the department, he filed this appeal before the Public Grievances Commission under Delhi Right to Information Act, 2001.

### **2. Proceedings**

The appellant is present and heard.

Shri Rajesh Sharma, EE (B)-II, SHS, EDMC, is present on behalf of the Competent Authority. The departmental representative submitted a letter dated 26/02/2020 vide which point-wise reply to the queries of the appellant has been furnished by the department. A copy of the same was provided to the appellant during the hearing today.

The information provided by the department has been perused and it appears that the department has provided satisfactory information to all the queries of the appellant.

### 3. Decision

Since the Competent Authority has provided satisfactory information to the queries of the appellant, no further information is required to be provided by the department in the present appeal case.

The department, in the reply, has informed that the property no. I-72, Gali No. 5, Garhwali Mohalla, Lalita Park, Laxmi Nagar, has been booked for unauthorized construction at ground floor till fourth floor on 31/05/2019. Though not a part of DRTI under reference, Deputy Commissioner (Shahdara South Zone), East DMC, is advised to initiate further action under the DMC Act, 1957, in respect of the booked property. An Action Taken Report may be submitted in the Commission for perusal within 4 weeks of receipt of this order.

Accordingly, the appeal case is ordered to be closed before the Appellate Authority / PGC.
