#### Brief facts of the complaint

1.1 Sh. Nishant Kumar has filed a grievance in PGC on 15.01.2020 regarding non payment of salary and other dues for the period w.e.f. 12.10.2019 to 20.12.2019 by M/s Amaze Courier Pvt. Ltd. He has worked as Dispatcher in the company.

#### 2. Facts emerged during the proceedings

- 1.1 Sh. Sanjay Kumar Gupta, Dy. Labour Commissioner is present in the hearing and has submitted an Action Taken Report dated 09.07.2020 stating therein that:-
  - "1. The complainant Sh. Nishant Kumar filed complaint before the Hon'ble Chairman, Public Grievances Commission on 15.01.2020.
  - 2. On perusal of complaint, it is found that it is related to non payment of due earned wages to complainant Sh. Nishant Kumar.
  - 3. Since the said complaint is more than 6 months old, before taking any action on the complaint, it was deemed appropriate to consult the complainant on given mobile no. regarding present status of his complaint.
  - 4. A telephonic call was made on given mobile no.8377944005 on 08.07.2020 at 3:22 PM which was picked by someone, who claimed himself as Sh. Nishant Kumar, complainant and stated that his dispute has been amicably settled with the management. He further stated that he does not want to pursue his case and wish to withdraw his complaint against management.

5. On the request of complainant, this complaint is disposed off by this office."

### 3. <u>Directions</u>

3.1 The case stands disposed of in the Commission as the complainant has settled his dispute regarding salary and other dues with the employer and does not want to pursue the case any further.
