1. Brief facts of the complaint

Sh. Harish has filed a grievance in PGC regarding non release of pensionary benefits of his deceased wife late Smt. Sukhbiri who had worked in EDMC as permanent sanitation worker and died on 02.10.2017.

2. Proceedings in the Public Grievances Commission

The PGC has convened four hearings in the matter and the next date of hearing was fixed as 25.03.2020. The same could not be held due to COVID-19 Pandemic situations. Hence a meeting was called for 24.07.2020 wherein Sh. R.C. Sahoo, Asstt. Commissioner, Shahadara Zone was advised to attend along with Action Taken Report in the matter.

3. Relevant facts that emerged during the hearing

3.1 Sh. Ramesh Sahoo, Assistant Commissioner, Shahadara South Zone, EDMC is present in the hearing and submitted a status report stating that
