1. Brief facts of the complaint

Sh. Genda Lal has filed a grievance in PGC on 08.07.2019 for non-payment of terminal benefits after retirement on 31.12.2018, as Sanitary Inspector from EDMC.

2. <u>Proceedings in the Public Grievances Commission</u>

The PGC has convened six hearings in the matter and next hearing was fixed for 14.04.2020 which could not be held due to COVID-19 pandemic situations.

Hence a meeting was called for 24.07.2020 wherein Sh. R.C. Sahoo, Asstt. Commissioner, Shahadara Zone was advised to attend along with Action Taken Report in the matter.

3. Relevant facts emerging during the hearing

3.1 Sh. Ramesh Sahoo, Assistant Commissioner, Shahadara South Zone, EDMC is present in the meeting and submitted a Status Report stating that
