1. Brief facts of the complaint

Dr. Surender Kumar Bhardwaj had filed a grievance in PGC on 13.12.2019 against the builder Sh. Hari Singh s/o late Chandgi, who has illegally encroached approx. 2 ft. on the public property (Street) and approx. 8 ft. on his land.

2. Proceedings in the Public Grievances Commission

The PGC has convened four hearings in the matter so far and in the hearing held on 14.10.2020, the following are present:

3. Relevant facts that emerged during the hearing

Sh. R.K.Verma, A.E. (Building), Narela Zone is present in the hearing and submitted a Status Report stating that

“The undersigned alongwith the concerned area Junior Engineer (B) and Junior Engineer (M), Narela Zone have visited the similar properties on 29.09.2020 & 09.10.2020 as indicated in para 3.2 of the order dated 16.09.2020 passed by this Hon’ble Commission to ascertain the extent of unauthorized construction and encroachment under complaint.

During the course of inspection, it was found that the existing construction / encroachment in lane within the vicinity i.e. H.No. 9,

Auchandi Road, Near Shivalaya Bawana Delhi were old and occupied having been carried out without obtaining sanctioned building plans. The details of such properties based on the site inspection are given below :-

House adjoining to Dr. Surender Bhardwaj, Auchandi Road, Near Old shivalaya, Village Bawana, Delhi	The property consists of ground floor, first floor with projection / chajja at ground and first floor on Govt. land approx. 3 feet. Besides above, there is ramp approx. 1.5-2 feet. The property is old and occupied.
4.	House adjoining to Sh. Hari Singh, Auchandi Road, Near Old Shivalaya, Village	The property consists of ground floor, first floor with projection / chajja at ground and first floor on Govt. land approx. 3 feet. Besides

The site enquiry revealed that the area in question falls in extended Ial dora area and therefore, ascertain the status of these properties including the ROW is to be determined and explained by the Revenue authorities.”

4. Recommendations of the PGC

As the matter is pending with ATMCD, Sh. R.K.Verma, Asstt. Engineer (B), Narela Zone is advised to take necessary action in the matter as per orders of the ATMCD and provisions of the DMC Act.

With the above directions the matter stands closed at the level of the Commission.
