### 1. Brief facts of the case

1.1 Shri Sanjeev Kumar, has filed a grievance petition before Public Grievances Commission (Dy.No.1352, 1404, 1429 dated 12<sup>th</sup> June, 2020) aggrieved by irregular timings in supply of water in B-Block, Gopal Nagar, Najafgarh by DJB and non-issuance of any schedule in this regard. He further stated that his K.No. is 6407838684 and his colony is getting contaminated water for the last many months. No action has been taken by officers of Delhi Jal Board so far despite repeated requests.
