1. Brief facts of the complaint

1.1 Shri Abhay Kumar, who is a student of Sri Chaitanya Educational Institute(Punjabi Bagh), has filed a grievance petition before the Public Grievances Commission, aggrieved by non-release of Monthly Stipend under the scheme of Jai Bhim Mukhyamantri Pratibha Vikas Yojna. It is stated in the complaint that as per this Scheme, there is a provision for providing monthly stipend of Rs.2500/- to student who are taking class under this Scheme. Hence, he requested for release of his stipend to enable him to take further classes provided by Shri Chaitanya Educational Institute.

2. Relevant facts emerging during the hearing

2.1 The representative of the respondent department filed an action taken report. He stated that the payment of monthly stipend amounting to Rs.5,000/- has been made to Sh.Abhay Kumar, the complainant.

Copy of Cheque No.104997 dated 16.03.2020 amounting to Rs.5,000/-drawn on Axis Bank, Vikaspuri, New Delhi, as well as acknowledgement from Shri Abhay Kumar in this regard has also been enclosed with the ATR.

- 2.2. The representative of the respondent department assured that in future also, monthly stipend will be disbursed to the student/complainant regularly subject to attending his classes physically. Further, as per policy, there is no provision of giving this monthly stipend for attending the classes on-line by the student.
- 2.3 The complainant is not present.

3. Directions of the PGC

3.1 In view of the prompt action taken by the respondent and the documents submitted in the Commission, the case of the complainant stands disposed of.
