# Order under Para 2(B) of the PGC Resolution No F.4/14/94-AR dated 25.9.97

#### 1. Brief facts of the complaint

1.1 Shri Vijay Narain has filed a grievance petition before Public Grievances Commission, aggrieved by non-receipt of re-employment pay because of non-fixation by the Dy.Director of Education(South), GNCTD. He has requested for Commission's intervention for direction to the respondent department for taking needful action promptly.

#### 2. Relevant facts emerging during the hearing

2.1 An action taken report has been flied by Dy.Director of Education(South). It has been stated in the report that:

"In the absence of specific guidelines/clarifications for pay fixation onreemployed, allowances in respect of Sh. Vijay Narain,TGT(Natural Science), re-employed under NPS for two years w.e.f. 01/07/2014 to 30/06/2016 could not be released.

On receiving the clarification from Govt.of India, pay of the said retired official has been fixed. Now, the concerned School Authority has informed that the details of total amount dues is as under:-

- a) Rs.2,10,480/- has already been released to the said retired official vide Bill No.APB-255 dated 20/01/2020.
- b) Bill bearing No.ABP-77 dated 31/08/2020 of remaining amount of Rs.4,01,724/- has been submitted in PAO-II, R.K. Puram, New Delhi, on 06/10/2020 for further disbursement to said retired official.

### 3. <u>Directions of the PGC</u>

3.1 In view of the prompt action taken by the respondent department in redressing the grievances of the complainant with regard to disbursal of his outstanding dues on account of his re-employment under NPS, the case stands disposed of in the Commission. However, if the complainant has any other grievance, he may file appropriate representation before the respondent department.
