**1. Brief facts of the case**

1.1 Sh.Nitin Sharma, complainant, R/o.H.No.570, 3<sup>rd</sup> Floor, Bhai Parmanand Colony, Delhi-110009 has filed a grievance petition before the Public Grievances Commission, aggrieved by inflated water bill in respect of K.No.5866501000. He has requested for rectification of the said water bill.

**2. Facts emerged during the proceedings.**

2.1 Zonal Revenue Officer(N)-I, Delhi Jal Board filed an action taken report. It is stated by him that the said bill is correct and issued on actual meter reading basis. Bill and consumption graph was also enclosed with the report.
