**Order under Para 2(B) of the PGC Resolution No F.4/14/94-AR dated 25.9.97**

**1. Brief facts of the case:**

1.1 Shri Jai Krishan Wadhwa has filed a grievance petition before Public Grievances Commission, aggrieved by non-revision of his pension as per 7<sup>th</sup> CPC recommendations despite repeated requests to Secretary, Directorate of Training & Technical Education, GNCT of Delhi. It further states that he had joined Delhi College of Engineering in 1954 and superannuated from there in 1984, after serving for 30 years.

The Delhi College of Engineering, now Delhi Technical University, functioned under administrative control of Deptt.of Training & Technical Education, Delhi Administration till the date of his retirement. He used to draw pension from Delhi Administration/GNCT of Delhi. He requested that his pension be revised as per Delhi Government Scheme, since he used to draw it from Delhi Administration even many years after his retirement. Necessary action in the matter should be initiated by Dte.of Training & Technical Education, GNCT of Delhi with regard to his grievance for revision of his pension as per 7<sup>th</sup> CPC.

**2. Facts emerged during the proceedings.**

2.1 An action taken report has been filed on behalf of Registrar, Delhi Technological University. It is stated in the report that “*the matter of revision of pension in r/o. Sh. J.K. Wadhwa, Ex-Lecturer as per 7<sup>th</sup> CPC was processed and sent to DTTE on 11.08.2020. The said file has now been received from DTTE on 19.10.2020 and accordingly, the case is being forwarded to PAO-X, Delhi Sachivalaya, GNCTD for necessary action.*”

2.2 The representative of the respondent department assured that he will personally handle the issue and get the proposal cleared from Pay & Accounts Office No.X, GNCTD today itself for necessary action.

2.3 The complainant expressed his satisfaction over action taken by the respondent department. He also thanked the Commission for redressal of his long pending grievances.

### **3. Directions**

3.1 In view of the action taken by the respondent department, the case of the complainant stands disposed of in the Commission with the direction that Registrar, Delhi Technological University shall ensure that the outstanding amount on account of revision of pension be disbursed to the complainant within 15 days time. A report in this regard shall be furnished to the Commission under intimation to the complainant.

3.2 The Pay & Accounts Officer No.X, GNCT of Delhi shall ensure that outstanding amount is released to the complainant within 15 days time positively.

3.3 The Pay & Accounts Officer No.XV, GNCTD, shall clear the proposal, if any, as per rules, on their part, for disposal of the case.

3.4 The complainant is advised to inform the Commission in writing as soon as he get his outstanding amount. In case the said amount is not received by him, he is at liberty to approach the Commission again for further necessary action.
