**Order under Para 2(B) of the PGC Resolution No F.4/14/94-AR**  
**dated 25.9.97**

**1. Brief facts of the complaint**

Sh. Deep Chand, IPS (Retd.) has filed a grievance in PGC on 22.10.2019 regarding dust pollution and open defecation on un-built roadside on Mehrauli-Mahipalpur road.

**2. Proceedings in the Public Grievances Commission**

The PGC has convened eight hearings in the matter so far and in the hearing held on 18.01.2021, the following are present:

Complainant : not called, being a senior citizen  
Respondent : Sh. Alok Kr. Mishra, Tehsildar  
Sh. Kharimullah.S, JE, PWD

**3. Relevant facts that emerged during the hearing**

3.1 Sh. Alok Kumar Mishra, Tehsildar (Mehrauli) is present in the hearing and submitted an Action Taken Report stating that :  
*"It is submitted that demarcation process of Mehrauli-Mahipalpur Road is completed by this office; however, some objections have been received through land owners / objectors. In this regard, a detail has been sent to ADM (South) wherein demarcation map,*

*objections and details of khara wise and area wise list of land which is covered in demarcation and likely for acquisition are enclosed for their further necessary action.”*

3.2 Sh. Kharimullah S., JE, PWD is present in the hearing and submitted reports from EE & AE stating respectively :

*“PWD deployed water tanker on the road for sprinkling water to settle the dust from time to time. Regarding acquisition of land, ADM South is doing the formalities as per present law, Sh. Alok Mishra, Tehsildar is fully cooperating and looking after the land acquisition.”*

*“In this regard some photos of road nearby Harcharan Bagh are hereby enclosed, as per directions given in the hearing on 30.12.2020 and it is also intimated that the land required for widening from Andheria More to D-1 Block is not handed over to PWD by the Revenue Department till date. The PWD will immediately start the work after getting the land and shall be completed within one month.”*

#### **4. Recommendations of the PGC**

4.1 ADM (South)/LAC is advised to start the process of acquisition of land and once acquired, handover the same to the PWD for widening of road.

4.2 Sh. A.K.Singh, Executive Engineer (South West Road) is advised to start the work of widening of road once the land, so acquired, is handed over by the LAC. In the meanwhile he is advised to take suitable measures to curb the dust pollution in the area

With the above directions the matter stands closed at the level of the Commission.
