Order under Para 2(B) of the PGC Resolution No F.4/14/94-AR dated 25.9.97

1. Brief facts of the complaint

Sh. Suresh Kumar Pamnani has filed a grievance in PGC on 14.11.2018 regarding illegal and unlawful sealing of third floor of property No. 3/18, East Patel Nagar, New Delhi by Deputy Commissioner, Karol Bagh Zone.

2. Proceedings in the Public Grievances Commission

The PGC has convened twelve hearings in the matter so far and in the hearing held on 16.12.2020, the following are present:

3. Relevant facts that emerged during the hearing

3.1 Sh. Jaipal, Asstt. Commissioner, Vigilance Department, North DMC is present in the hearing and submitted a status report.

3.2 The Commission observed that the report filed by the Vigilance Officer was vague and it seems that vigilance officers were trying to shield the delinquent officers. The matter was discussed telephonically

with the CVO, North DMC who assured that a detailed report will be submitted to the Commission.

3.3 Sh. S.K.Sharma, Asstt. Engineer (B), Karol Bagh Zone was present in the hearing and informed that the next date of hearing in the appeals filed by the complainant in the ATMCD is 18.02.2021. He was advised to provide a copy of complaints in the ATMCD, to the Commission.

3.4 The Vigilance Department has submitted a detailed and final report dated 21.01.2021. Sh. S.K.Sharma, Asstt. Engineer (B), Karol Bagh Zone has provided copies of complaints filed by the complainant. Appeal Number 438/2012 was filed by the complainant against the Sealing Order by North DMC and Appeal Number 635/2019 was filed against the Demolition Order of North DMC.

4. Recommendations of the PGC

As the matter is sub-judice, the same stands closed at the level of the Commission with the advice to the Deputy Commissioner, Karol Bagh Zone to further proceed in the matter as per the orders of the ATMCD.
