1. Brief facts of the case

1.1 Shri Sanjay Kumar Singh filed a grievance petition aggrieved by non-execution of Recovery Certificate amounting to Rs. 87,692/- plus 10% simple interest from date of recovery w.e.f. 29.07.2016 from the management of M/s. Eagle Hunter Solutions Ltd. 61-C, Kalu Sarai, Sarvpriya Vihar, New Delhi. The Recovery Certificate dated 06.09.2017 was forwarded by the Controlling Authority, Payment of Gratuity Act, 1972, in respect of its orders dated 02.08.2017 to District Collection Officer, District South, Revenue Department, GNCT of Delhi.

2. Facts emerged during the proceeding:

2.1 Shri V.K. Rao, Labour Officer is present and submitted a reply under his signature stating that the cheque/DD No. 06900 of Rs. 1,33,739/- has been released to the complainant/claimant Shri Sanjay Kumar Singh on 18.01.2021. Copy of demand draft alongwith proof of receipt of DD by Shri Sanjay Kumar Singh, complainant has been enclosed.

3. Directions

In pursuance of recovery certificate of Rs. 87,692/- alongwith 10% simple interest p.a. w.e.f. 29.7.2016 to till it is paid, a demand draft of Rs. 133,739/- was recovered by SDM (Hauz Khas). The demand draft was forwarded to the Controlling Authority under Payment of Gratuity Act/Deputy

Labour Commissioner, District South, Labour Department.

Department.has handed over the demand draft of Rs.
1,33,739/- to the complainant on 18.1.2021. As such, the
grievance is redressed. Accordingly, the grievance case is
