1. Brief facts of the case

1.1 Shri Mohan Atray filed a grievance petition before this Commission against illegal submersible pump installed at Tummy Section, Jail Road, Near Om Sweets, New Delhi-1100018. It has been further stated in the petition that personal submersible pumps have been banned by NGT which leads to wastage of ground water.

2. Facts emerged during the proceedings.

2.1 An action taken report has been filed on behalf of Executive Engineer(West)-I, Delhi Jal Board. It is stated in the report that “..The aforesaid illegal borewell has been sealed by SDM Rajouri Garden on 12.02.2021.”

2.2 A report has been filed on behalf of Sub-Divisional Magistrate(Rajouri Garden). It is stated that “..The said illegal borewell was sealed on 12.02.2021. Further, in compliance of the PGC’s directions dated 25.01.2021, following action was taken:-

- i) Team comprising of Tehsildar(RG), JE(DJB) and BSES staff visited the site for re-inspection and sealed the borewell.*
- ii) Penalty of Rs.50,000/- has been imposed as Environment Damage Compensation.*
- iii) Concerned SHO has been directed to register an FIR for submitting false affidavit.”*

Copy of the Sealing memo dated 12.02.2021 and photographs have been enclosed with the report.

2.3 The complainant is not present.

3. Directions :

3.1 In view of the action taken by the Office of Sub-Divisional Magistrate(Rajouri Garden) and Delhi Jal Board, against the illegal borewell at Tummy Section, Jail Road, Near OM Sweets, New Delhi, the case stands disposed of in the Commission.
