1. Brief facts of the case

1.1 Shri Sanjay Kumar filed a grievance petition before the Public Grievances Commission aggrieved by inflated water bills. It is stated in the grievance petition by the complainant that he has three water meters in each floor at his premises at A-25, Shish Ram Park, Uttam Nagar, New Delhi but for the last two and three months, his bill is coming too high as such Rs.14,000/- to 15,000/- in respect of K.No.8809581000. But in respect of other two meters, bill is zero. Despite assurance, no relief has been provided by the respondent department.

2. Facts emerged during the proceedings.

2.1 Shri Vijay Kumar, Zonal Revenue Officer(West)-III, Delhi Jal Board, filed an action taken report. It is stated in the report that *"the Bill of the consumer against water connection K.No.9978581000 running at A-25-26, Shish Ram Park, has been rectified as per*

documents provided by the consumer, Mr.Sanjay, and the same has been delivered to him.”

Copy of the bill dated 03rd July, 2021 amounting to Rs.5230/- has also been enclosed with action taken report.

2.2 The representative appearing on behalf of the complainant was made aware of this fact who expressed his satisfaction.

3. Directions :

3.1 In view of the action taken by the respondent department with regard to rectifying the water bill in respect of the complainant's meter, the case stands disposed of in the Commission.
