**1. Brief facts of the complaint**

1.1 Sh. Vinod Kumar Chauhan has filed a grievance petition before Public Grievances Commission, aggrieved by non-release of salary for the month of September and October, 2016 by G.B.SSS No.2, from where he retired as Vice Principal.

**2. Relevant facts emerging during the hearing**

2.1 Sh. Sanjeev Kumar, H.O.S, G.B.S.S.S. No.2, Mansarovar Park, Shahdara, Delhi - 110032 was present in the hearing and filed a status report dated 19.07.2021 stating in the report that

*"The undersigned has already sent a file to Higher Authority on 05.04.2021 vide No. GBSSSNo-2/MSP/2021/152 and vide No.1192 dated 12.04.2021 (DDE N/E II office), the same file was sent to the Regional Director of Education for seeking directions about his salary arrear and overpayment matter but due to prolonged lockdown period, this file could not be received back in the school so far. As soon as the file is received, immediate action in this regard will be taken by the undersigned as per the directions of the Higher Authorities."*

**2.2 THE DEPARTMENTAL REPRESENTATIVE SUBMITTED THAT THE DISCREPANCY REGARDING OVERPAYMENT TO THE COMPLAINANT WAS NOTICED BY HIM WHEN DUE DRAWN STATEMENT IN RESPECT OF THE COMPLAINANT WAS PREPARED BY THE ACCOUNTS OFFICE OF THE SCHOOL FOR HIS PAY FIXATION. THE SCHOOL HAS**

WRITTEN FOUR LETTERS TO THE COMPLAINANT FOR FURNISHING REPLIES FOR RECOVERY OF OVERPAYMENT DONE TO HIM BUT TILL DATE, NO REPLY WAS RECEIVED FROM THE COMPLAINANT.

2.3 THE COMPLAINANT PRESENT STATED THAT HE WANTS TO WITHDRAW HIS PRESENT CASE IN THE COMMISSION AND DOES NOT WANT TO PURSUE THE MATTER REGARDING NON RELEASE OF SALARY FOR THE MONTH OF SEPTEMBER AND OCTOBER, 2016 BY THE SCHOOL.

3. **Directions of the PGC**

3.1 The complainant categorically submitted during the hearing that he was not interested in pursuing the matter for non-release of salary for the month of September and October, 2016 by the school G.B.S.S.S. No.2, Mansarovar Park, Shahdara. He further requested Sh. Sanjeev Kumar, H.O.S, G.B.S.S.S. No.2, Mansarovar Park for dropping the case regarding recovery of overpayment done to him. The department representative acceded to the request of the complainant.

3.2 As the complainant is not interested in pursuing the case, the case is disposed of in the Commission.
